- ✓ **NO PERSONS UNDER 21 ALLOW ON THE TRAILS UNLESS UNDER DIRECT SUPERVISION OF THERE MOTHER/FATHER OR NATURAL GUARDIAN.**
- ✓ **ONLY IDLING SPEED ON THE FARM ROADS TO WHERE THE TRAILS START.**
- ✓ **DO NOT DEVIATE FROM THE ROUTES. NO DRIVING AROUND ON THE FARM ROADS, OR IN THE CAMPS.**

- ✓ No to and fro driving through the rivers, vlei or any other areas.
- ✓ No firewood may be taken from the veldt – order from the reception office prior to arrival.
- ✓ The use of firearms is strictly forbidden and will be severely prosecuted.

- ✓ Quads/Bikes must be back in Bundu Camp no later than 18:00.
